New Business-

The City Hall sign was taken down last summer when the hall was painted and never put up as it was in bad shape. Council feels a new one should be put up. Mayor Schatz will look into prices and let council know how much it would cost at next meeting.

Resident Kathrin Volochenko had purchased two properties in town this last year, which they are not livable. They would like to dig up the sewer and disconnect the water, and not pay for those charges anymore. Council member Fiedler makes a motion to approve Volochenko's disconnecting their water and sewer and not being charged, Zinke seconded it. Motion carried.

Lane Zinke would like a building permit to put up a shop in the extra lot next to Randy Zinke. Volochenko makes motion to approve building permit. Fiedler seconded it. Motion carried.

Engineer, AJ Tuck sent Pay Estimate 8 for Scherbenske for board to look over. Board decides to table decision till AJ can attend and explain.

Residents are concerned about other residents not mowing their lawns and letting it get out of control. Council will look into ordinances and see if the City has anything at this time.

Jamie Meidinger wanted the board to know that she was notified all park board members retired and will no longer be involved with it. Board told her you don't really need a board, just a few people that residents can go to if they have questions or concerns.

Volochenko makes motion to adjourn. Wagner seconded it. Meeting adjourned.
