Mclean Sheridan is updating their software for their billing program and Ann is wondering if the city would like to keep using the RVS program she has been for our billing since we don't have many residents, or if we would like to change the program to Black Mountain. If Mercer continues to stay with current program it would be around \$1,000 a year for applicable fees. If City changes to Black Mountain we could be looking at a few thousand dollars a month. Thomsen makes motion to stay with RVS program, city will be responsible for fees, and Zinke seconded it. Motion called.

Council member Zinke talked with Scott from NDIRF regarding claim filed for sewer line damage on Max Street, and last thing Scott stated he was going to come to town and look at damage. City hasn't heard anything from him.

Council members decide to have 701 Dirt works blade the roads in town, once we get some moisture.

Ken Thomsen talked with Tracy Schilling and they will not be building the C-store at this time.
