The lawyer felt to make it more legal according the ordinance the curb stop should be put in so residents could have access to the water if they have to pay. Mayor Fiedler, would like to know how many residents were marked on the loan to pay and aren't paying, and have never paid. Council members will look at current curb-stops and compare to rate study and make a decision going forward.

Council members would like to look into getting a new lawyer for the City. Council members will call around and see what they can come up with.

The state is requiring each City to adopt a back Flow prevention program. Mayor Fiedler met with Ward Heidbreder, from ND Rural Water systems Association, to discuss what needs to be done. He suggested the City go forward with the Comprehensive program, with this program we already have it set up. Once City decides which program, then we will need to adopt an ordinance. Auditor would like to send letter to residents to get information updated. Thomsen makes motion, Jim seconded it. Motion carried.

Volochenko makes motion to adjourn meeting, Jim seconded it. Randy opposes. Motion carried.
